Scheduling for the 2024-2025 school year will begin on January 17. Teachers will be entering their course recommendations in Aspen. Students and parents may view teacher recommendations in the Aspen Student Portal under the **My Info** top tab and **Requests** side



tab or Aspen Family Portal under the **Family** top tab, **Schedule** side tab and **Requests** side tab. Course selection sheet links were sent to all rising seniors, juniors, and sophomores via MHRD email.

Starting on January 17, the school counselors will begin scheduling individual meetings with their counselees, starting with rising seniors, followed by rising juniors, and finally rising sophomores. Finalized course selections for the upcoming school year can always be viewed in the Aspen Student or Family Portals after individual meetings are held.
